**Prospective members must submit to a background check;** Federal and State, either from the Fairfield County Sheriff's Office or another office from the Ohio Attorney General's approved list, clear of any violations of law restricting possession of firearms. **In lieu of a background check**, a prospective member may provide evidence of eligibility such as, but not limited to, an FFL, C&R license, an Ohio CHL or a CHL/ CCW permit from a state that has reciprocity with Ohio. Additionally, a prospective member may provide proof of employment that would require a background check and possession of firearms as part of their employment. This would include, but not limited to, Police Officers, Sheriff or Sheriff Deputy. **The cost of the background check is the responsibility of the prospective member.** The background check documentation shall be returned to the applicant after review by the membership committee.
