~~Tim Nead presented some new facts about the ATF and state regulations. Any purchaser of a firearm without a CCW will probably have a visit by a Sheriff's Deputy to process an identity check.~~

Should be:

For a NICS check without CCH, address will have to be entered when processing the 4473, IF the background check is a [denial or delay](#), Co. Sheriff and ATF notified. If delay removed, no action. **If a denial, Co. Sheriff will visit for the attempt to obtain a firearm under disability.** Good news: they are taking background checks more seriously. Law abiding citizens, no worries. For the first time, if denied, a reason will be provided. The denial notification will include the date and time of the denial, the reason for the denial, the location of the federal firearms licensee (FFL), and the identity of the person. The NICS denial notifications will be transmitted electronically to the appropriate receiving authorities within each state based on the city, state, county, and zip code combination of the FFL location and the city, state, county, and if different, the zip code combination of the attempted transferee's home address. If at any time, the original denial is changed to a proceed, an updated notification to those agencies originally notified will be required

Member Recognition:

Eric Hysell was recognized for his donation of a large quantity of fuel oil to the club for our heaters, and also for his continuing participation at our work parties.

Rule Review:

The use of shotguns at the range was discussed. Initial sighting in of slug guns can be done in the rifle house on the first two positions with the concrete benches, further adjustments should be done at the rifle range. Patterning of shotguns should be done at the 50ft range in the pistol house with care being taken not to inflict damage to the berm. All target stands shall be repaired after use.
