2020 - Straw pistol and rifle backstop, stone for parking lot

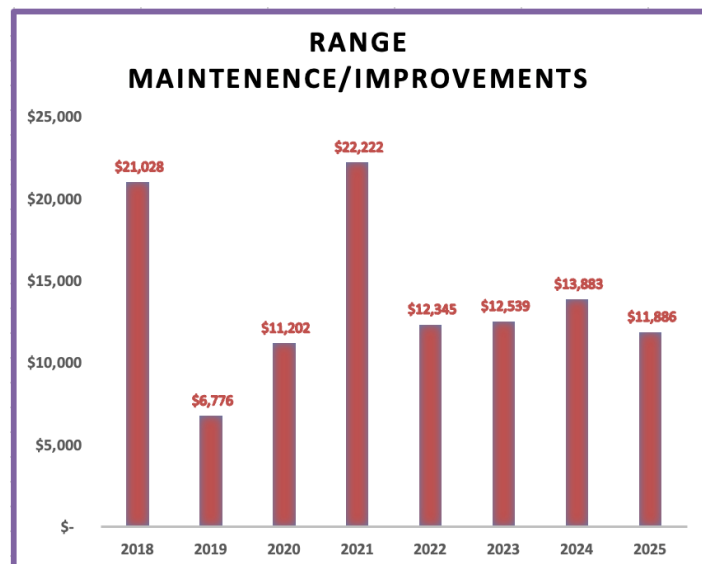
2021 - Re-build 50 yd and 50 ft bunkers, and paint and install new windows in the pistol house
